In year late 1999, a new legislation titled the Consumer Protection Act 1999 was created and formulated the establishment of the **Tribunal for Consumer Claims**. This Tribunal was formed to cater and act as a channel or an alternative dispute resolution for consumers to make claims or losses from suppliers or manufacturers easier, cheaper and faster than the court process, therefore the motto of the Tribunal – **“Easy, Cheap & Quick”**.

At the end of year 2002, the **Tribunal for Home Buyer Claims** was formed under the Housing Development (Control and Licensing) (Amendment) Act 2002. A total of 23,315 claims have been filed at the Tribunal up to 31 March 2008. Over time, changes have been made to enhance the jurisdictions, ambit and scope of these Tribunals.

This Seminar explains in layman terms the workings of the respective Tribunals, common cases and enforcements of awards and is ideally suited for anybody who is expecting to be involved in the Tribunals without legal counsel and those believing in the adage: **“Investment in knowledge pays the best interest”**.
